Molten Metals ("MM") is a world leader in the mining and processing of antimony and tin.

MM's commitment to socially responsible business practices includes the promotion of responsible supply chains.

MM is committed to the principles of the Responsible Minerals Initiative (RMI) and its predecessor-organizations as part of its eorts to help eliminate unlawful and unethical minerals trade. The RMI brings together leading companies from industries including aerospace, automotive and electronics, who support the Responsible Minerals Assurance Program (RMAP) and commit to the promotion of responsible supply chains for all minerals.

DRIVE AWARENESS

MM's processing sites in Slovakia, are conformant to the regulations of the country.

Our mission is to drive awareness throughout industries so that all conflicted materials are eliminated from supply chains. To full this mission MM commits to the following actions:

 Adhere to the Organization for Economic Cooperation and Development (OECD) 5-Steps Due Diligence Guidance for Responsible Supply Chains of Minerals from Conict-Aected nd High-Risk Areas (CAHRAs) and the 14 points of its Annex II Model Supply Chain Policy addressing: serious abuses associated with the extraction, transport or trade of minerals, direct or indirect support to non-state armed groups, public or private security forces, bribery and fraudulent misrepresentation of the origin of minerals, and payment of taxes, fees and royalties due to government. Thus our risk management includes, among others:continuing trade throughout the course of measurable risk management eorts, temporarily suspending trade while pursuing ongoing mitigation eorts, and disengaging with a supplier in cases where mitigation appears not feasible or unacceptable

Devise appropriate risk mitigation strategies for above risks, including: meetings with suppliers, mine site visits and cooperation stakeholders like the RMI, OECD, International Tin Association (ITA) iTSCi program to establish credible eective processes to eliminate non-ethical mining and trade through enhanced due diligence, and allow continuation of legitimate mining activities in CAHRAs.

Engage in open communication with stakeholders and support ongoing eorts by relevant authorities that have the potential to bring improvements in living conditions and economic stability in conflict-regions.

Comply with applicable legislation such as the U.S. Dodd-Frank Wall Street Reform and Consumer Protection Act (July, 2010) and the European Union regulation on conict minerals. These laws seek to sever the link between minerals' mining and social conicts by encouraging responsible trade of minerals sourced from the Democratic Republic of the Congo (DRC) and from other identied CAHRAS.

RESPONSIBLE MINING

Require that shipments of our products containing the materials adhere to the appropriate domestic and international transportation regulations such as the rules for Class 7 Radioactive Materials. MM advocates that the tin and antimony industry also complies with these international regulations.

We encourage all organizations involved in mining, trade, processing, or the use of antimony/ tin products to join us in promoting responsible supply chains for tin and antimony.
